IV. Officer Reports

A. President

- 1. BOG Meetings
 - Going well; schedule time to meet with Ava if you haven't yet
 - Committee chairs need to meet with their committees before November meeting
 - Constituent concerns should be posted on Facebook from now until November meeting—hoping that this will expedite meetings

B. Vice President

- 1. Org Update
 - Mehek and Ziebarth have been meeting with reps from each org and will compile a report once meetings are completed
- 2. SBA Blackboard page
 - Ziebarth is working with IT to create an SBA blackboard page in which all students will be automatically enrolled—stay tuned!

C. Treasurer

- 1. Org Budgets
 - Had \$50,450 for semester
 - Allocated 417,497 to orgs in September
 - \$7,150 allocated to committees in September (social and H&W)
 - \$25,303 remaining (before allocating budgets at October meeting)
 - MOTION (Kennedy): Move \$1,000 into ABA Travel account and \$1000 into student travel account (Second Guevara)
 - Passes with 4 abstentions (Gutnik, Newhauser, Kennedy, Cavaco)

D. Secretary

- 1. MOTION (Kerr): Approve September Meeting minutes (Seconded Newhauser)
 - Passes with one abstention (Cavaco)

 - 1. Committee Budgets
 - Posted on Facebook and sent out via email

- MOTION (Kerr): Approve Committee budgets as posted on Facebook and sent out via email (seconded Mehek)
 - Passes with four abstentions (Newhauser, Cavaco, Strafaccia, Karim)

2. SELS request

- Asks for \$700
- Newhauser proposes \$500 to comply with \$50/\$100 limits, and cutting miscellaneous
 - MOTION (Humphrey): Approve SELS \$500 (Second Gutnik)
 - Passes with two abstentions (Cavaco, Newhauser)

2. CLS clarification

- Asks for \$2870
- Newhauser proposes \$1295 to comply with 50/100 limits
- Approved \$1150 after cutting Hybrid coffee in November so as not to interfere with other planned breakfast and finals breakfast in April (SBA already provides this)
- MOTION (Guevara): Approve CLS budget at \$1150 (Second Moos)
 - Passes with one Nay (LaLor), two abstentions (Cavaco, Newhauser)

3. Appeals

a. APALSA

- Appealed for \$700 for Chinese New Year event
- MOTION (Burkitt): Approve \$700 appeal (Second Kennedy)
 - Passes with one nay (LaLor), three abstentons (Newhauser, Cavaco, Guevara)

b. BLSA

- Appealed for \$500
 - Strictly for MABL table—this amount was originally denied because SBA was given the impression by the Multicultural office that they were providing the table. It was learned that MCO was purchasing a table but only for faculty/staff, no students
- MOTION (Kennedy): Approve \$500 appeal (Second Humphrey)
 - Passes with two abstentions (Newhauser, Cavaco)

c. HLS

- Appealed for \$3,640 for Aid in Dying Panel
- Board has many concerns about event:

- HLS has been told many times that SBA will only fund students, yet HLS is looking to SBA to fund the event for ALL attendees, including those who attend for CLE credit
- concern about effort from HLS to secure funding from another source (HLI)
- did not take into account ANY suggestions from E-Baord about practical ways to budget/plan this event (ex. Don't need to buy tablecloths, centerpieces on every table are unnecessary, cost of dinner is excessive)
- Event would take place at the same time as Health Law Compliance class, leaving out 30 students who may otherwise attend AND 1Ls will be in lawyering
- The number of expected students is generous; SBA will limit to 70 students at \$10/head to comport with same number for APALSA Chinese New Year event
- MOTION (Kerr): Approve \$700 appeal (Second Strafaccia)
 - Passes with two nays (Kennedy, Johnson) and three abstentions (Guevara, Cavaco, Newhauser)
