Myrna also offers training courses on traumainformed engagement for leaders, policy makers, police officers, lawyers, and judges. She has also become a

highly sought-after public speaker.

Myrna has co-edited two publications: Criminal Law eBook Canadian Law, Indigenous Laws and Critical Perspectives, published by CanLII (set for release on March 28, 2023), and Trauma-Informed Law: a Pathway to Healing and Resilience for Lawyers, published by the American Bar Association (set for release in April 2023).
