This unique combination will increase the value of your J.D., because Mitchell Hamline's program is accredited by the Compliance Certification Board. Certificate holders will be eligible to sit for the nationally recognized Certified in Healthcare Compliance exam.

Students can choose to earn the Health Law Certificate, the Health Care Compliance Certificate, or both certificates.
