

Request to Add Publication

Please use this form to register for publication. **A registration form must be submitted each term in order to confirm credit allocation and good academic standing. This form should be submitted by the add deadline for the selected term.** The credits must be awarded in the academic year in which the work is completed and cannot be added to or dropped from a term after the term has ended. MHSL's credit hour policy for co-curricular activities is as follows:

Academic credit will be awarded for work on a law review, journal, competition team, internship with a professor, or other co-curricular activity upon determination that the student has completed at least 45 hours of work per credit hour awarded. Students are responsible for tracking their time according to the policies and procedures that apply to the activity involved. Prior to submitting grades for co-curricular activities, faculty advisors, competition coaches, or supervising faculty members are responsible for verifying that each student has logged sufficient hours to justify the award of academic credit to that student.

Effective Fall 2018, students must be in good academic standing to participate in a publication.

The faculty supervisor or publication Editor-in-Chief must sign to verify eligibility to enroll in the credits indicated.
