Please join us for an upcoming panel presentation discussing recent executive actions taken by the Trump Administration and other actions under consideration to eliminate lawful pathways and terminate legal status and work authorization of recent immigrant arrivals granted by the Biden administration. These recent executive actions include: revocation of the Venezuelan TPS extension issued by outgoing DHS Secretary Mayorkas and termination of the 2023 Venezuelan TPS designation by DHS Sec. Noem, termination of the Cuba, Haiti, Nicaragua, Venezuela (CHNV) Humanitarian Parole Program and CBPOne App Appointments and Parole at the U.S./Mexico border, proposed measures to terminate grants of humanitarian parole by the Biden administration to CHNV humanitarian parolees and CBPOne app humanitarian parolees, and proposed use of expanded expedited removal against these populations. The panel will also discuss the economic impact of these recent and proposed executive actions by the Trump administration terminating the lawful status and work authorization held by these recent immigrant arrivals.

Ana Pottratz Acosta is a Professor of Law at Mitchell Hamline School of Law in St. Paul, MN where she teaches Immigration Law, Professional Responsibility and the Health Law Clinic, which provides representation to indigent clients using the Medical Legal Partnership model. Ana also serves as Supervising Attorney responsible for overseeing the Medical-Legal Partnership program between Mitchell Hamline and Riverland Community Health, a Federally Qualified Healthcare (FQHC) facility in St. Paul, MN. Immediately prior to joining Mitchell Hamline, Ana practiced at Stinson Leonard Street LLP as an attorney in the immigration law group where she represented clients in employment-based immigration matters and supervised non-immigration attorneys on pro bono immigration matters for clients of the Deinard Clinic, the firm's pro bono program providing legal services to patients of the University of Minnesota Community University Health Care Center (CUHCC). Additionally, from 2004 to 2010, Ana served as an immigration attorney for Lutheran Social Services of New York (LSSNY) Immigration Legal Services Program where she provided direct legal services to low-income immigrant populations in New York City. Ana also served for two years, from 2008 to 2010, as supervisor of the LSSNY Refugee Resettlement Program, where she worked with LSSNY staff and volunteers to provide reception and placement services to newly resettled refugees. Ana is a 2004 graduate of Columbia Law School and a 2001 graduate of the University of Minnesota.

Abdiwahab Mohamed is a professional working in economic development who currently serves as the Assistant Commissioner of the Office of New Americans, a new state agency within the Minnesota Department of Employment and Economic Development (DEED). Within the Office of New Americans, Assistant Commissioner Mohamed has developed and implemented a strategic framework to include immigrants and refugees in MN in economic development initiatives, coordinate with other state agencies and external stakeholders to realize inclusion initiatives and integration of new Americans into the workforce, and reduce barriers to economic development. Prior to serving as Assistant Commissioner of the Office of New Americans, Assistant Commissioner Mohamed worked as a Senior Grants and Performance Specialist for the State of Minnesota and with the Minnesota Trade Office to support economic growth in Minnesota through international trade and foreign investment. Aron D. Thorn Speaker Bio

Aron D. Thorn is a Senior Attorney in the Beyond Borders Program at the Texas Civil Rights Project (TCRP). He has been based in the Rio Grande Valley of Texas for over ten years, the last 5 years in his role with TCRP. Prior to joining TCRP, Aron was an in-house civil lawyer with the County of Hidalgo, Texas, one of the largest counties by population on the Texas-Mexico border. Aron engages in federal and state impact litigation related to the militarization of the border, which affects both those migrating through the borderlands, and those who call the border home.

Aron's work in this capacity has included: working with families separated on the border under the Zero Tolerance policy, filing a class action challenge to the placement of individuals with disabilities in the Migrant Protection Protocols, advocating for just policies at the 88th Texas Legislature, a legal challenge to Texas's Senate Bill 4, passed in 2023, purporting to give State officials de facto deportation authority, defending non-profit organizations from harassing investigations undertaken by the Texas Attorney General, and dozens of Know-Your-Rights presentations to immigrant communities throughout the Rio Grande Valley and the South Texas region.
