#### **APPLICATIONS OVERVIEW**

### SUMMER LAW INTERN PROGRAM AND ATTORNEY GENERAL'S HONORS PROGRAM

- Centralized Process
- Fill-in, online application, includes:
  - Program Eligibility Questions
  - Rank up to three formal participants, check a box for informal
  - Practice Area Interests
  - **Education**
  - Professional Accomplishments and Experience
  - Honors and Awards
  - **Employment**
  - References
- Applicants upload their law school transcript (unofficial accepted)
- Answer essay questions:
  - > "Why do you want to work for the Department of Justice and what attracts you to the components you selected?" (4,000 characters)
  - > "If you could tell the selecting official one thing about yourself, what would it be?" (2,000 characters)
- Application opens July 31 and closes on September 8, 2019


